Definitions for Eligibility, for Reference:

- “MVPs” require a competitor to perform in a scored role at the highest level of team competition achieved by MMT
 - Unofficial Timers are not eligible at state; nationals roster would supersede state
 - Rule was built during the first MVP year, formalizing in the record book
- “Performer” is defined by making an introduction – even if unscored – during a tournament
 - Rule was established in 2017 as a result of Ben Shaw & Tiffany Tam reaching various eligibility thresholds; no back-application needed
- “Case Prep” eligibility involves preparing through the 50% prep time, competing a substantial scrimmage, or competing at the tournament
 - Rule was formalized in 2017, but has been applied since Christina Wadsworth in 2012 for Providence
 - 6 students were invited to prep and scrimmage the Collegiate Natls Case for 2018; this was worth a .5 of a case prep
- “Awards” include any HM/Ranks at any recognized tournament; Providence Cup “final round” awards (given to the best attorney and witness who participated in the final round) do not count; the Menlo MVP award counts; Gladiator Competitors (but not understudies) are automatically given an award for earning and accepting a bid
